## **CITY OF TORONTO**

### **BY-LAW 781-2025**

#### **To amend City of Toronto Municipal Code Chapter 950, Traffic and Parking, respecting Emerson Avenue.**

The Council of the City of Toronto enacts:

1. Municipal Code Chapter 950, Traffic and Parking, is amended as follows:

A. By deleting from Schedule XIII (No Parking) in § 950-1312, the following in alphabetical order by street name:

(From Column 1 Highway)	(From Column 2 Side)	(From Column 3 Between)	(From Column 4 Prohibited Times and/or Days)
Emerson Avenue	East	A point 68 metres north of Bloor Street West and Paton Road	Anytime from Dec. 1 of one year to Mar. 31 of the next following year, inclusive, and from the 16th day to the last day of each month from Apr. 1 to Nov. 30, inclusive
Emerson Avenue	East	Bloor Street West and a point 68 metres north	Anytime
Emerson Avenue	East	Paton Road and Dupont Street	16th day to the last day of each month from Apr. 1 to Nov. 30, inclusive
Emerson Avenue	West	A point 83.8 metres north of Bloor Street West and Dupont Street	First day to the 15th day of each month, from Apr. 1 to Nov. 30, inclusive
Emerson Avenue	West	Paton Road and Dupont Street	Anytime from Dec. 1 of one year to Mar. 31 of the next following year, inclusive

B. By inserting in Schedule XIV (No Stopping) in § 950-1313, the following in alphabetical order by street name:

Emerson Avenue	Bloor Street West and Paton Road	Easterly Northbound	Anytime	Northbound (bicycles only)

Emerson Avenue	Paton Road and Wallace Avenue	Easterly Northbound	Anytime	Northbound

Wallace Avenue and Emerson Avenue	Eastbound and Westbound	Right and Left	Anytime (bicycles excepted)

F. By inserting in Schedule XXVII (Compulsory Stops) in § 950-1326, the following in alphabetical order by street name:

(In Column 1 Intersection)	(In Column 2 Stop Street or Highway)
Dupont Street and Emerson Avenue	Emerson Avenue (northbound)
Lappin Avenue and Emerson Avenue	Emerson Avenue (northbound)
Emerson Avenue and Millicent Street	Emerson Avenue (northbound)
Armstrong Avenue and Emerson Avenue	Emerson Avenue (northbound)
