## **CITY OF TORONTO**

### **BY-LAW 1029-2025**

#### **To amend City of Toronto Municipal Code Chapter 950, Traffic and Parking, respecting Blue Jays Way.**

The Toronto and East York Community Council enacts:

1. Municipal Code Chapter 950, Traffic and Parking, is amended as follows:
- A. By inserting in Schedule XIII (No Parking) in § 950-1312, the following in alphabetical order by street name:
