**BY-LAW 1367-2025**

**To amend City of Toronto Municipal Code Chapter 950, Traffic and Parking, respecting  
 Dundas Street West.**

The Council of the City of Toronto enacts:

1. Municipal Code Chapter 950, Traffic and Parking, is amended as follows:

A. By deleting from Schedule XIII (No Parking) in § 950-1312, the following in  
 alphabetical order by street name:

(From Column 1 Highway)	(From Column 2 Side)	(From Column 3 Between)	(From Column 4 Prohibited Times and/or Days)
Dundas Street West	North	Indian Grove and Abbott Avenue	7:00 a.m. to 9:00 a.m., Mon. to Fri., except public holidays
Dundas Street West	South	Annette Street and a point 120 metres west	Anytime
Dundas Street West	South	Indian Grove and a point 120 metres west of Annette Street	4:00 p.m. to 6:00 p.m., Mon. to Fri., except public holidays

 order by street name:

C. By deleting from Schedule XIV (No Stopping) in § 950-1313, the following in alphabetical order by street name:

Dundas Street West	South	A point 75 metres west of Annette Street and Roncesvalles Avenue	7:00 a.m. to 9:00 a.m., Mon. to Fri., except public holidays

Dundas Street West (TO)	North and East	Indian Grove and Bloor Street West	9:00 a.m. to 4:00 p.m.	1 hour
Dundas Street West	South	Indian Grove and a point 120 metres west of Annette Street	9:00 a.m. to 4:00 p.m.	1 hour
