CITY OF TORONTO

BY-LAW 1534-2025

To amend City of Toronto Municipal Code Chapter 950, Traffic and Parking, respecting Sheppard Avenue East and Willowdale Avenue.

The Council of the City of Toronto enacts:

1. Municipal Code Chapter 950, Traffic and Parking, is amended as follows:

A. By deleting from Schedule XIII (No Parking) in § 950-1312, the following in alphabetical order by street name:

(From Column 1 Highway)	(From Column 2 Side)	(From Column 3 Between)	(From Column 4 Prohibited Times and/or Days)
Sheppard Avenue East	North	Yonge Street and a point 112 metres west of the driveway access at No. 650 Sheppard Avenue East (located opposite Grenbriar Road)	Anytime
Sheppard Avenue East	South	Doris Avenue and Bessarion Road	Anytime
