BY-LAW 101-2026

**To amend City of Toronto Municipal Code Chapter 950, Traffic and Parking, respecting
Cocksfield Avenue and Sheppard Avenue West.**

The Council of the City of Toronto enacts:

1. Municipal Code Chapter 950, Traffic and Parking, is amended as follows:

A. By deleting from Schedule XIII (No Parking) in § 950-1312, the following in
alphabetical order by street name:

(From Column 1 Highway)	(From Column 2 Side)	(From Column 3 Between)	(From Column 4 Prohibited Times and/or Days)
Cocksfield Avenue	South	Wilmington Avenue and Goddard Street	Anytime
Sheppard Avenue West	North	Wilson Heights Boulevard and a point 90 metres west of Goddard Street	7:00 a.m. to 9:00 a.m. and 4:00 p.m. to 6:00 p.m., Mon. to Fri., except public holidays

B. By inserting in Schedule XIII (No Parking) in § 950-1312, the following in alphabetical
order by street name:

(In Column 1 Highway)	(In Column 2 Side)	(In Column 3 Between)	(In Column 4 Prohibited Times and/or Days)
Cocksfield Avenue	South	A point 165 metres east of Wilmington Avenue and Goddard Street	Anytime
Cocksfield Avenue	South	Wilmington Avenue and a point 60 metres east	Anytime

(In Column 1 Highway)	(In Column 2 Side)	(In Column 3 Between)	(In Column 4 Prohibited Times and/or Days)
Sheppard Avenue West	North	Wilson Heights Boulevard and a point 37 metres east of Wilmington Avenue	7:00 a.m. to 9:00 a.m. and 4:00 p.m. to 6:00 p.m., Mon. to Fri., except public holidays
Sheppard Avenue West	North	A point 99 metres east of Wilmington Avenue and a point 90 metres west of Goddard Street	7:00 a.m. to 9:00 a.m. and 4:00 p.m. to 6:00 p.m., Mon. to Fri., except public holidays

C. By inserting in Schedule XIV (No Stopping) in § 950-1313, the following in alphabetical order by street name:

(In Column 1 Highway)	(In Column 2 Side)	(In Column 3 Between)	(In Column 4 Prohibited Times and/or Days)
Cocksfield Avenue	North	A point 60 metres east of Wilmington Avenue and a point 105 metres further east	Anytime
Cocksfield Avenue	South	A point 60 metres east of Wilmington Avenue and Goddard Street	Anytime
Sheppard Avenue West	North	A point 37 metres east of Wilmington Avenue and a point 62 metres further east	Anytime

D. By deleting from Schedule XVIII (One-Way Highways) in § 950-1317, the following in alphabetical order by street name:

(From Column 1 Highway)	(From Column 2 Between)	(From Column 3 Times and/or Days)	(From Column 4 Direction)
Cocksfield Avenue	Wilmington Avenue and a point 183 metres east of Wilmington Avenue	Anytime	Westbound

E. By inserting in Schedule XVIII (One-Way Highways) in § 950-1317, the following in alphabetical order by street name:

(In Column 1 Highway)	(In Column 2 Between)	(In Column 3 Times and/or Days)	(In Column 4 Direction)
Cocksfield Avenue	Wilmington Avenue and Goddard Street	Anytime	Westbound
