BY-LAW 102-2026

To amend City of Toronto Municipal Code Chapter 950, Traffic and Parking, respecting Courcellette Road and Kingston Road.

The Council of the City of Toronto enacts:

1. Municipal Code Chapter 950, Traffic and Parking, is amended as follows:
 - A. By deleting from Schedule XIV (No Stopping) in § 950-1313, the following in alphabetical order by street name:

(From Column 1 Highway)	(From Column 2 Side)	(From Column 3 Between)	(From Column 4 Prohibited Times and/or Days)
Courcellette Road	East	Kingston Road and a point 31.9 metres south	Anytime
Courcellette Road	West	Kingston Road and a point 47.7 metres south	Anytime
Kingston Road	South	Fallingbrook Road and Wood Glen Road	4:00 p.m. to 6:00 p.m., Mon. to Fri., except public holidays
Kingston Road	South	Victoria Park Avenue and Courcellette Road	4:00 p.m. to 6:00 p.m., Mon. to Fri., except public holidays
Kingston Road	South	Courcellette Road and Fallingbrook Road	Anytime

- B. By inserting in Schedule XIV (No Stopping) in § 950-1313, the following in alphabetical order by street name:

(In Column 1 Highway)	(In Column 2 Side)	(In Column 3 Between)	(In Column 4 Prohibited Times and/or Days)
Kingston Road	Sout	Victoria Park Avenue and Wood Glen Road	4:00 p.m. to 6:00 p.m., Mon. to Fri., except public holidays

- C. By deleting from Schedule XV (Parking for Restricted Periods) in § 950-1314, the following in alphabetical order by street name:

(From Column 1 Highway)	(From Column 2 Side)	(From Column 3 Between)	(From Column 4 Time and/or Days)	(From Column 5 Maximum Period Permitted)
Kingston Road	South	Blantyre Avenue and Courcellette Road	Anytime	1 hour
Kingston Road	South	Fallingbrook Road and Wood Glen Road	Anytime	1 hour
