CITY OF TORONTO

BY-LAW 174-2026

To amend City of Toronto Municipal Code Chapter 950, Traffic and Parking, respecting Rosemount Avenue and St. John's Road.

The Toronto and East York Community Council enacts:

1. Municipal Code Chapter 950, Traffic and Parking, is amended as follows:
 - A. By deleting from Schedule XIII (No Parking) in § 950-1312, the following in alphabetical order by street name:

(From Column 1 Highway)	(From Column 2 Side)	(From Column 3 Between)	(From Column 4 Prohibited Times and/or Days)
Rosemount Avenue	North	Dufferin Street and Oakwood Avenue	Anytime
Rosemount Avenue	North	Oakwood Avenue and a point 35.1 metres west of Alberta Avenue	16th day to the last day of each month, from Apr. 1 to Nov. 30, inclusive
Rosemount Avenue	South	Oakwood Avenue and a point 50.3 metres west of Alberta Avenue	Anytime, from Dec. 1 of one year to Mar. 31 of the next following year, inclusive
Rosemount Avenue	South	Oakwood Avenue and a point 50.3 metres west of Alberta Avenue	First day to the 15th day of each month, from Apr. 1 to Nov. 30, inclusive
St. John's Road	South	A point 72.9 metres east of Priscilla Avenue (west intersection) and a point 7.3 metres east thereof	Anytime

B. By inserting in Schedule XIII (No Parking) in § 950-1312, the following in alphabetical order by street name:

(In Column 1 Highway)	(In Column 2 Side)	(In Column 3 Between)	(In Column 4 Prohibited Times and/or Days)
Rosemount Avenue	North	Oakwood Avenue and a point 38.4 metres west of Alberta Avenue	16th day to the last day of each month, from Apr 1 to Nov 30, inclusive
Rosemount Avenue	South	Oakwood Avenue and a point 38.4 metres west of Alberta Avenue	Anytime, from Dec 1 of one year to Mar 31 of the next following year, inclusive
Rosemount Avenue	South	Oakwood Avenue and a point 38.4 metres west of Alberta Avenue	First day to the 15th day of each month, from Apr 1 to Nov 30, inclusive

C. By inserting in Schedule XVI (No Standing) in § 950-1315, the following in alphabetical order by street name:

(In Column 1 Highway)	(In Column 2 Side)	(In Column 3 Between)	(In Column 4 Prohibited Times and/or Days)
Rosemount Avenue	North	Northcliffe Boulevard and Oakwood Avenue	Anytime
