BY-LAW 231-2026

To amend City of Toronto Municipal Code Chapter 950, Traffic and Parking, respecting Labatt Avenue and River Street.

The Council of the City of Toronto enacts:

1. Municipal Code Chapter 950, Traffic and Parking, is amended as follows:

A. By deleting from Schedule XIII (No Parking) in § 950-1312, the following in
alphabetical order by street name:

(From Column 1 Highway)	(From Column 2 Side)	(From Column 3 Between)	(From Column 4 Prohibited Times and/or Days)
Labatt Avenue	North	A point 40.5 metres east of River Street and the east end of Labatt Avenue	Anytime

B. By inserting in Schedule XIII (No Parking) in § 950-1312, the following in alphabetical
order by street name:

(In Column 1 Highway)	(In Column 2 Side)	(In Column 3 Between)	(In Column 4 Prohibited Times and/or Days)
Labatt Avenue	North	River Street and the east end of Labatt Avenue	Anytime

C. By deleting from Schedule XIV (No Stopping) in § 950-1313, the following in alphabetical order by street name:

(From Column 1 Highway)	(From Column 2 Side)	(From Column 3 Between)	(From Column 4 Prohibited Times and/or Days)
Labatt Avenue	Both	River Street and a point 40.5 metres east	Anytime
River Street	East	Labatt Avenue and a point 46.1 metres north	Anytime

D. By deleting from Schedule XV (Parking for Restricted Periods) in § 950-1314, the following in alphabetical order by street name:

(From Column 1 Highway)	(From Column 2 Side)	(From Column 3 Between)	(From Column 4 Time and/or Days)	(From Column 5 Maximum Period Permitted)
Labatt Avenue	South	A point 40.5 metres east and the east end of Labatt Avenue	8:00 a.m. to 6:00 p.m., Mon. to Fri.	1 hour

E. By inserting in Schedule XV (Parking for Restricted Periods) in § 950-1314, the following in alphabetical order by street name:

(In Column 1 Highway)	(In Column 2 Side)	(In Column 3 Between)	(In Column 4 Time and/or Days)	(In Column 5 Maximum Period Permitted)
Labatt Avenue	South	River Street and the east end of Labatt Avenue	8:00 a.m. to 6:00 p.m., Mon. to Fri.	1 hour

F. By deleting from Schedule XXVII (Compulsory Stops) in § 950-1326, the following in alphabetical order by street name:

(From Column 1 Intersection)	(From Column 2 Stop Street or Highway)
Labatt Avenue and Defries Street	Labatt Avenue
