## **CITY OF TORONTO**

### **BY-LAW 306-2026**

#### **To amend City of Toronto Municipal Code Chapter 950, Traffic and Parking, respecting Davies Avenue and Hamilton Street.**

The Toronto and East York Community Council enacts:

1. Municipal Code Chapter 950, Traffic and Parking, is amended as follows:

A. By deleting from Schedule XIII (No Parking) in § 950-1312, the following in alphabetical order by street name:
