BY-LAW 315-2026

To amend City of Toronto Municipal Code Chapter 950, Traffic and Parking, respecting Charles Street West.

The Toronto and East York Community Council enacts:

1. Municipal Code Chapter 950, Traffic and Parking, is amended as follows:
- A. By inserting in Schedule VI (Commercial Loading Zones) in § 950-1305, the following in alphabetical order by street name:

(In Column 1 Highway)	(In Column 2 Side)	(In Column 3 Location)	(In Column 4 Times and/or Days)
Charles Street West	South	Between a point 17 metres west Yonge Street and a point 15 metres further west	9:30 a.m. to 12:00 p.m. and 7:00 p.m. to 10:00 p.m.

- B. By deleting from Schedule XIII (No Parking) in § 950-1312, the following in alphabetical order by street name:

(From Column 1 Highway)	(From Column 2 Side)	(From Column 3 Between)	(From Column 4 Prohibited Times and/or Days)
Charles Street West	North	Yonge Street and Balmuto Street	8:00 a.m. to 6:00 p.m., Mon. to Sat.
Charles Street West	South	Balmuto Street and Yonge Street	Anytime

C. By inserting in Schedule XIII (No Parking) in § 950-1312, the following in alphabetical order by street name:

D. By inserting in Schedule XIV (No Stopping) in § 950-1313, the following in alphabetical order by street name:

Charles Street West	North	Balmuto Street and a point 23 metres east	Anytime
Charles Street West	South	Balmuto Street and St Nicholas Street	Anytime

E. By deleting from Schedule XV (Parking for Restricted Periods) in § 950-1314, the following in alphabetical order by street name:

(From Column 1 Highway)	(From Column 2 Side)	(From Column 3 Between)	(From Column 4 Time and/or Days)	(From Column 5 Maximum Period Permitted)
Charles Street West	North	Balmuto Street and Yonge Street	6:00 p.m. of one day to 8:00 a.m. of the next following day, Mon. to Sat.	1 hour

F. By inserting in Schedule XV (Parking for Restricted Periods) in § 950-1314, the following in alphabetical order by street name:

(In Column 1 Highway)	(In Column 2 Side)	(In Column 3 Between)	(In Column 4 Time and/or Days)	(In Column 5 Maximum Period Permitted)
Charles Street West	South	A point 32 metres west of Yonge Street and a point 9 metres east of St Nicholas Street	Anytime	1 hour

G. By inserting in Schedule XVI (No Standing) in § 950-1315, the following in alphabetical order by street name:

(In Column 1 Highway)	(In Column 2 Side)	(In Column 3 Between)	(In Column 4 Prohibited Times and/or Days)
Charles Street West	North	A point 23 metres east of Balmuto Street and Yonge Street	Anytime

H. By deleting from Schedule XVIII (One-Way Highways) in § 950-1317, the following in alphabetical order by street name:

(From Column 1 Highway)	(From Column 2 Between)	(From Column 3 Times and/or Days)	(From Column 4 Direction)
Charles Street West	Yonge Street and Balmuto Street	Anytime	Westbound
