## **CITY OF TORONTO**

### **BY-LAW 592-2026**

#### **To amend City of Toronto Municipal Code Chapter 950, Traffic and Parking, respecting Church Street and Maitland Street.**

The Toronto and East York Community Council enacts:

1. Municipal Code Chapter 950, Traffic and Parking, is amended as follows:
