## **CITY OF TORONTO**

### **BY-LAW 861-2026**

#### **To amend City of Toronto Municipal Code Chapter 950, Traffic and Parking, respecting Trinity Street.**

The Toronto and East York Community Council enacts:

1. Municipal Code Chapter 950, Traffic and Parking, is amended as follows:

A. By inserting in Schedule V (Stands for Taxicabs) in § 950-1304, the following in alphabetical order by street name:

| Trinity Street              | West                     | Between a point 9 metres south of Front Street East and a point 50 metres South of Front Street East | 6                                         | Anytime from and including Thu. Nov. 12, 2026 to and including Sun. Jan. 3, 2027 |

B. By inserting in Schedule XIV (No Stopping) in § 950-1313, the following in alphabetical order by street name:

| (In<br>Column 1<br>Highway) | (In<br>Column 2<br>Side) | (In<br>Column 3<br>Between)             | (In<br>Column 4<br>Prohibited Times and/or Days)                                 |
|-----------------------------|--------------------------|-----------------------------------------|----------------------------------------------------------------------------------|
| Trinity Street              | East                     | Front Street East and Mill Street       | Anytime from and including Thu. Nov. 12, 2026 to and including Sun. Jan. 3, 2027 |
| Trinity Street              | West                     | Mill Street and a point 28 metres north | Anytime from and including Thu. Nov. 12, 2026 to and including Sun. Jan. 3, 2027 |

C. By inserting a new Subsection (13) in § 950-1202A as follows:

"(13) During the time frame indicated in the entry in Subsection 1A to 1B, inclusive, of By-law 861-2026, the provisions of Subsections 1A to 1B of By-law 861-2026 shall apply notwithstanding anything to the contrary in any other by-law or chapter of the Municipal Code. For further clarity, where any regulation contained in Subsection 1A to 1B, inclusive, of By-law 861-2026 conflicts with any other regulation in any Schedule of Municipal Code Chapter 950, Traffic and Parking, the regulation as found in By-law 861-2026 shall prevail during the time frame outlined in the regulation as found in By-law 861-2026."
