BY-LAW 865-2026

To amend City of Toronto Municipal Code Chapter 950, Traffic and Parking, respecting Ontario Street.

The Toronto and East York Community Council enacts:

1. Municipal Code Chapter 950, Traffic and Parking, is amended as follows:

A. By deleting from Schedule XIII (No Parking) in § 950-1312, the following in alphabetical order by street name:

(From Column 1 Highway)	(From Column 2 Side)	(From Column 3 Between)	(From Column 4 Prohibited Times and/or Days)
Ontario Street	East	Gerrard Street East and a point 143 metres south	Anytime

B. By inserting in Schedule XIII (No Parking) in § 950-1312, the following in alphabetical order by street name:

(In Column 1 Highway)	(In Column 2 Side)	(In Column 3 Between)	(In Column 4 Prohibited Times and/or Days)
Ontario Street	East	A point 69 metres south of Gerrard Street East and a point 74 metres further south	Anytime

- C. By inserting in Schedule XIV (No Stopping) in § 950-1313, the following in alphabetical order by street name:

(In Column 1 Highway)	(In Column 2 Side)	(In Column 3 Between)	(In Column 4 Prohibited Times and/or Days)
Ontario Street	East	Gerrard Street East and a point 69 metres south	Anytime
Ontario Street	West	Gerrard Street East and a point 69 metres south	Anytime

- D. By deleting from Schedule XV (Parking for Restricted Periods) in § 950-1314, the following in alphabetical order by street name:

(From Column 1 Highway)	(From Column 2 Side)	(From Column 3 Between)	(From Column 4 Time and/or Days)	(From Column 5 Maximum Period Permitted)
Ontario Street	West	Dundas Street East and Gerrard Street East	8:00 a.m. to 6:00 p.m., Mon. to Fri.	1 hour

- E. By inserting in Schedule XV (Parking for Restricted Periods) in § 950-1314, the following in alphabetical order by street name:

(In Column 1 Highway)	(In Column 2 Side)	(In Column 3 Between)	(In Column 4 Time and/or Days)	(In Column 5 Maximum Period Permitted)
Ontario Street	West	Dundas Street East and a point 69 metres south of Gerrard Street East	8:00 a.m. to 6:00 p.m., Mon. to Fri.	1 hour

F. By deleting from Schedule XVIII (One-Way Highways) in § 950-1317, the following in alphabetical order by street name:

(From Column 1 Highway)	(From Column 2 Between)	(From Column 3 Times and/or Days)	(From Column 4 Direction)
Ontario Street	Gerrard Street East and Dundas Street East	Anytime	Southbound

G. By inserting in Schedule XVIII (One-Way Highways) in § 950-1317, the following in alphabetical order by street name:

(In Column 1 Highway)	(In Column 2 Between)	(In Column 3 Times and/or Days)	(In Column 4 Direction)
Ontario Street	A point 60 metres south of Gerrard Street East and Dundas Street East	Anytime	Southbound

2. This By-law shall be effective commencing October 31, 2026.
