BY-LAW 883-2026

To amend City of Toronto Municipal Code Chapter 950, Traffic and Parking, respecting Gilbert Avenue.

The Toronto and East York Community Council enacts:

- 1.** Municipal Code Chapter 950, Traffic and Parking, is amended as follows:
- A.** By deleting from Schedule XIII (No Parking) in § 950-1312, the following in alphabetical order by street name:

(From Column 1 Highway)	(From Column 2 Side)	(From Column 3 Between)	(From Column 4 Prohibited Times and/or Days)
Gilbert Avenue	East	A point 11 metres south of Corby Avenue and a point 5.5 metres north thereof	Anytime
Gilbert Avenue	East	A point 88.5 metres south of Summit Avenue and a point 6 metres north thereof	Anytime
Gilbert Avenue	West	A point 173.3 metres south of Rogers Road and Rogers Road	Anytime
Gilbert Avenue	West	Norman Avenue and a point 124.9 metres north of Innes Avenue	Anytime

B. By inserting in Schedule XIII (No Parking) in § 950-1312, the following in alphabetical order by street name:

(In Column 1 Highway)	(In Column 2 Side)	(In Column 3 Between)	(In Column 4 Prohibited Times and/or Days)
Gilbert Avenue	East	A point 36 metres north of Innes Avenue and a point 10 metres further north	Anytime
Gilbert Avenue	West	Norman Avenue and Rogers Road	Anytime

C. By deleting from Schedule XXX (Heavy Vehicles Prohibited) in § 950-1329, the following in alphabetical order by street name:

(From Column 1 Highway)	(From Column 2 Between)	(From Column 3 Prohibited Times and/or Days)
Gilbert Avenue	A point 173.3 metres south of Rogers Road and Summit Avenue	Anytime
Gilbert Avenue	Norman Avenue and a point 124.2 metres north of Innes Avenue	Anytime

D. By inserting in Schedule XXX (Heavy Vehicles Prohibited) in § 950-1329, the following in alphabetical order by street name:

(In Column 1 Highway)	(In Column 2 Between)	(In Column 3 Prohibited Times and/or Days)
Gilbert Avenue	Norman Avenue and Rogers Road	Anytime
