2010 Municipal Election – Candidates with Court Extensions in Default

SUMMARY

At its meeting of April 12 & 13, 2011, Council received the report entitled 2010 Municipal Election - Candidates in Default (Item CC7.3) for information. Some candidates, having been unable to meet the statutory deadline for financial filings, sought court extensions. The purpose of this report is to advise Council of the 2010 municipal election candidates who failed to file their required financial statements by the individual court-imposed deadlines after seeking extensions for such filings. The penalties for these candidates in default include being ineligible to be elected or appointed to any office to which the *Municipal Elections Act, 1996* (the *Act*) applies until after the next regular (2014) election has taken place.

COMMENTS

Under the *Act*, all candidates in the 2010 municipal election are required to file a financial statement by the legislated deadline of 2:00 p.m. on March 25, 2011. The *Act* also permits candidates in a deficit at the end of their campaign to apply to the Ontario Court of Justice to extend the time for filing their financial statement for up to 90 days after the legislated deadline. Candidates who fail to file a financial statement by the court-imposed deadline are also in default of the *Act* and subject to penalties under the *Act*.

Subsection 80(3) of the Act requires the Clerk to notify Council of any candidates who are in default of the Act.

A candidate is in default if he or she:

- fails to file the required financial statement and/or auditor's report by the relevant date;
- fails to pay to the Clerk the surplus amount shown on the face of their financial statement by the relevant date; or
- has incurred expenses exceeding what is permitted under the Act.

A candidate in default is ineligible to be elected or appointed to any office to which the *Act* applies until the next regular election has taken place. In addition, if a candidate is an elected official, they forfeit the office to which they were elected and the office is deemed to be vacant.

Attached in Appendix "A" is a list for Council's information of the candidates who ran for the office of councillor and were in default of the individual court-imposed deadline. These individuals are unable to run for office until the next regular (2014) election has taken place.

As required under the *Act*, the Clerk has sent notice to each candidate, advising they are in default and of the penalties involved.
