Provision of collection, transportation and off-loading of Garbage, Bulky Items, Recyclable Materials, Organic Materials and Yard Waste from curb side collected single family homes, Multi-residential locations, day collection commercial locations, Charities, Institutions and Religious Organizations (CIROs), and Agencies, Boards, Commissions, Departments (ABC&Ds) in the area bounded by Yonge Street to the east, the Humber River to the west, Steeles Avenue to the north and Lake Ontario to the south.

Knowles Consulting Services Inc. (Knowles) was engaged by the City of Toronto as Fairness Advisor to provide independent oversight throughout the procurement process to select a Supplier for the Provision of collection, transportation and off-loading of Garbage, Bulky Items, Recyclable Materials, Organic Materials and Yard Waste from curb side collected single family homes, Multi-residential locations, day collection commercial locations, Charities, Institutions and Religious Organizations (CIROs), and Agencies, Boards, Commissions, Departments (ABC&Ds) in the area bounded by Yonge Street to the east, the Humber River to the west, Steeles Avenue to the north and Lake Ontario to the south. Knowles participated in the validation of the procurement process and provided oversight throughout the process.

## Observations and Findings

The City of Toronto's Purchasing and Materials Management Division (PMMD) and Solid Waste Division staff managed the RFQ process. PMMD and the Solid Waste Division prepared the draft and final RFQ documentation and addenda, responded to proponent questions, conducted Bidders' information meetings as well as site visits and consulted Knowles as Fairness Advisor for potential and actual fairness issues. In accordance with the RFQ, all communications with the City during the open period were conducted in writing by email with a designated buyer in the Purchasing and Materials Management Division (PMMD) and a deadline for questions was established. Responses were provided by way of addenda to the RFQ.

Four Bidders submitted five separate, timely quotations in response to the RFQ. All five quotations met all mandatory submission requirements. One quotation was rejected because the submission was qualified: the Bidder took exception to the City's terms and conditions. The four conforming quotations were less than the minimum cost savings threshold of \$25,975,030.00 per annum stipulated in the RFQ. The four quotations were ranked in order of price and the lowest was selected by City staff for negotiation of a Contract.

## Conclusion

As the Fairness Advisors for Request for Quotation No. 6033-11-3186, we certify that the RFQ procurement process was, in our opinion, fair, open and transparent and that Bidders received consistent treatment. Furthermore, we are not aware of any issues that would impair the fairness of this procurement.
