**Community Service Partnerships Program – 2011
Allocation Recommendations for New and Increased
Requests**

SUMMARY

This report provides recommendations on requests for both new program funding and increased program funding under the 2011 Community Service Partnerships (CSP) program. The CSP provides ongoing support to programs run by community based organizations that advance Council's strategic goals and priorities by working to improve social outcomes for vulnerable, marginalized and high-risk communities. Each year, applications are solicited from organizations that demonstrate a fit with the CSP's funding criteria. These criteria identify whether organizations have the capacity to govern accountably, deliver effective programs, and involve the community in decision making.

For 2011, 228 eligible organizations requested a total of \$15,890,471.69 to support the operation of community programs. These requests include a total of \$2,376,705.69 for new or increased support from 78 organizations for 148 programs.

This report recommends the allocation of \$4,658,646.00 to the 78 organizations that requested new and increased program support. Of these recommended funds, \$28,000.00 will be used to support enhanced programming in one program, and the remainder will be used to maintain existing programs at 2010 operating levels.

A total of \$35,135.00 of the approved CSP 2011 Operating Budget has been held for appeals by organizations of recommendations for new and increased funding. An additional \$12,000.00 has been held to administer claims by eligible seniors in the former City of York for snow shovelling services.

RECOMMENDATIONS

The Executive Director, Social Development, Finance and Administration recommends that:

1. City Council approve 2011 Community Service Partnerships allocation recommendations totalling \$4,658,646.00 for the 78 organizations that requested new and increased funding as described in Appendices A and D. Included in this amount is \$28,000.00 in increased program funding for one program.
2. An amount of \$35,135.00 be held from the CSP 2011 approved Operating Budget for appeals of recommendations for new and increased funding.
3. An amount of \$12,000.00 be held from the CSP 2011 approved Operating Budget to administer claims by eligible seniors in the former City of York for snow shovelling and lawn care services.
4. City Council delegate authority to the Executive Director, Social Development, Finance and Administration to re-allocate 2011 CSP funds that are not used during the funding year by approved organizations to another CSP approved organization.
5. The Executive Director, Social Development, Finance and Administration report on any re-allocation of 2011 CSP funds to City Council in the 2012 CSP allocation report.

Financial Impact

The recommendations contained in this report will not result in financial implications beyond what has been approved in the 2011 Approved Operating Budget.

The CSP and the Major Recreation program are administered jointly through an on-line application system and the CSP application review process. The Community Partnership and Investment Program (CPIP) 2011 Approved Operating Budget includes \$12,689,430.00 for the Community Service Partnerships program, and \$1,048,200.00 for the Major Recreation program, for a total of \$13,737,630.00.

As part of the transition of the Major Recreation program administration, allocations for four organizations that received funding under the Major Recreation program but not under the CSP program in 2010 are not addressed in this report. Recommendations for these organizations will be addressed as a part of the Community Recreation Investment program 2011 allocations report, which is also before the Community Development and Recreation Committee at its June 29, 2011 meeting. A corresponding amount of \$214,739.00 from the Major Recreation program approved budget will be allocated as a part of the Community Recreation program report.

Under the Council-approved streamlining policy for grants administration, once Council has approved the Annual Operating Budget, the Executive Director, Social Development, Finance and Administration has delegated authority to approve flat-line allocations for organizations that do not request new or enhanced funds. A total of \$8,817,110.00 for 150 organizations has been approved by the Executive Director under this delegated authority. These flat-line allocations include \$8,158,780.00 under the CSP program, and \$658,330.00 under the Major Recreation program.

The allocations of all organizations that request new or increased funding must be approved by Council under the streamlining policy for grants administration. This report recommends that \$4,658,646.00 be allocated to the 78 applicants that submitted requests for new or increased program funding to the CSP and Major Recreation programs. A total of \$35,135.00 has been held from the CSP program operating budget to address appeals of these recommendations.

As a part of the approved incorporation of snow shovelling and lawn care programs for seniors and disabled adults into the CSP, Council approved a legacy model of service delivery for existing clients of the program in the former City of York. An amount of \$12,000.00 has been held from the CSP 2011 Approved Operating Budget to administer claims by eligible clients for snow shovelling and lawn care services.

The Deputy City Manager and Chief Financial Officer has reviewed this report and agrees with the financial impact information.

DECISION HISTORY

Community Service Partnerships provides ongoing support to organizations that work to improve social outcomes for vulnerable, marginalized and high-risk communities.

In June 2008, Council approved the report "Options to Streamline and Improve Funding Administration" and provided direction to implement changes in the application and approval processes for CPIP Partnership programs.

In November 2009, Council approved the report "CPIP 2009 Community Services Funding Recommendations and Program Update" which approved the transfer of Food Security Investment Program (FSIP) funding to the Community Service Partnerships program, starting with the 2010 cycle. Council directed that the CSP annual report include a summary of funded programs that address food security issues, and that the FSIP grant size cap be maintained within the CSP envelope for transferred projects.

In July, 2010, Council approved the report "2010 Snow Shovelling and Lawn Care Program Allocation Recommendations" providing direction to administer the program as part of Community Service Partnerships program, starting with the 2011 funding cycle. Council also directed that the program grant size cap be maintained within the Community Service Partnership envelope for currently funded programs.

EQUITY IMPACT STATEMENT

The Community Service Partnerships supports and sustains the well being of Toronto's communities by providing funding to community based organizations for programs that address its mission to improve social outcomes for vulnerable, marginalized and high-risk residents and communities. Funding applications are solicited from organizations that have identified a local need related to the program's mandate, and have designed a local response that is effective, leverages other financial resources, and involves volunteers and participants in all organizational activities. By working through community based organizations, the City supports a broader range of targeted services and engagement opportunities for ethno-cultural communities and equity seeking groups than it would be able to offer on its own.

The CSP portfolio includes 228 programs serving the Aboriginal, ethno-specific, or multi-ethnic population groups. A total of \$5,914,853.00, or 44 percent of the total CSP and Major Recreation operating budget, is allocated to these programs. These programs are provided by 3 Aboriginal and 73 ethno-specific/multi-ethnic organizations, as well as by 53 other organizations. A total of 76 organizations, or 34 percent of the 226 organizations funded under the CSP and Major Recreation program are Aboriginal, ethno-specific, or multi-ethnic.

ISSUE BACKGROUND

Over the years, Toronto has developed a very sophisticated human service system. This system is a mixed model that has moved away from an exclusive reliance on municipal service delivery to one based on partnerships between the City, community based organizations, and for-profit service providers. As a part of these partnerships, the City purchases services that reach out to all parts of Toronto to work with changing populations, identify evolving community needs and develop flexible, innovative and cost-effective ways of meeting them.

The City uses Community Partnership and Investment Program (CPIP) funding to purchase services when resident-governed organizations are the most knowledgeable about the community-specific expertise required to effectively advance Council's goals and priorities. In these situations, CPIP programs reflect Council strategic goals and priorities (such as social inclusion, community safety, youth development, and a vibrant local economy), and community based organizations propose the services that will advance these goals across or within specific communities and neighbourhoods.

The CSP is used to purchase services that improve social outcomes for vulnerable, marginalized and high-risk residents and communities. It operates as an ongoing funding program, providing a stable environment in which residents can work together over time to improve outcomes in their communities.

The CSP program is regularly reviewed to ensure its ongoing effectiveness as means of purchasing services and improving community outcomes. Program guidelines and

administrative practices are modified to address changes in City goals, emerging community issues, and in response to broader trends such as the economic recession or rising unemployment rates. The Community Partnership Strategy is being developed to provide a comprehensive planning framework for assessing local priorities and allocating resources, further strengthening the CSP's ability to improve social outcomes.

The CSP guidelines are posted on the City's website at www.toronto.ca/grants/csp. These guidelines define the CSP's mission, and explain the organizational and program eligibility criteria that are used to assess organizations and their programs. Information about the CSP allocation process and other resources for applicants are also available on the program's web page.

The authority to use Community Service Partnerships funding as means of purchasing service arises from the general authority for making municipal grants provided in Section 83 of the *City of Toronto Act, 2006* (S.O. 2006, c.11).

COMMENTS

Community Partnership Strategy

As a standard part of its due diligence practices, the CSP and other CPIP programs assess and monitor the strength of the community based organizations that they purchase services from. These assessments are conducted with a variety of tools, including funding criteria, risk management frameworks, contracts and letters of understanding, site visits, reports, and policies in areas as diverse as financial management and anti-racism. These tools allow the City to better understand the strength of individual organizations, and help them maximise the impact that City resources have on community needs.

The City is currently working to extend its monitoring and assessment capacity with the development of the Community Partnership Strategy. When fully developed, the Strategy will provide the City with a tool to assess and monitor how well community services are working as a system in neighbourhoods. Unlike the City's existing tools, the Strategy does not focus on the functioning of individual organizations, but rather provides a means for understanding the way the full range of community based organizations and services work together to support residents in their neighbourhoods.

In partnership with the Centre for Research on Inner City Health (CRICH), staff recently completed consultations with more than 250 residents, funders and community organizations to determine what the City should pay attention to so that it knows how well the community service system is working in neighbourhoods. This process resulted in 51 key ideas that constituents believe the City should monitor. The ideas ranked as the most important across all stakeholder groups include:

- Community service users are satisfied
- Community services are offered at convenient times for the users
- Neighbourhood residents know about the community services that are available

- Community services are offered in convenient locations for neighbourhood residents
- Community organizations have stable funding
- Community organizations make the best use of the assets and resources in the neighbourhood to provide services
- Community organizations take extra steps to reach out to residents who are isolated, so they can use services
- Community organizations tailor services for the unique needs of the neighbourhood (e.g. social, cultural and economic)
- Community organizations create a welcoming environment (e.g., friendly staff, inviting spaces)

Staff are now in the process of identifying appropriate data that will allow the City to monitor the key ideas about the community service system that are most important to residents, funders and agencies. Once these measures are developed, the Strategy will provide a fact base that will allow the CSP and other CPIP programs to better assess the impact of funding across the community service sector, and plan for future investments that build the strength of the service delivery system in neighbourhoods.

Community Service System Planning and Outcome Measurement

In the CRICH-led Community Partnership Strategy consultations, residents, funders and agencies identified a number of important outcomes that they believe a strong community service system in neighbourhoods contributes to. These constituents identified outcomes such as a good education, improved health, safe neighbourhoods with low crime rates, reduced neighbourhood unemployment rates, and secure incomes as areas where the community service system has a significant contribution to make to neighbourhood wellbeing.

One of the goals of the Community Partnership Strategy is to better understand the contribution that the community service system in neighbourhoods has on the outcomes that are important to residents, funders and agencies, and to Council. This kind of information would allow the CSP and other CPIP funding programs to prioritize their investments in the community service system, and help to establish long term planning processes that maximise the impact that CPIP funding has on neighbourhood outcomes.

The CSP's understanding of the impact of its funding on the community service system and on positive neighbourhood outcomes will be developed using the Community Partnership Strategy in combination with Wellbeing Toronto. Wellbeing Toronto is an online, interactive mapping tool that provides neighbourhood level data across ten different subject areas: Civics, Culture, Economics, Education, Environment, Health, Housing, Recreation, Safety, and Transport. It brings together a wide variety of operational metrics, socio-demographic information and service infrastructure data to provide an indicator tool that can be used to support a variety of neighbourhood-focused planning processes of the City, other governments, other funders, community agencies, and residents. The June 29, 2011 meeting of the Community Development and

Recreation Committee includes a presentation that introduces the system to Councillors and the public.

The power of Wellbeing Toronto lies not simply in its ability to provide an accurate, common fact base for use in current planning processes, but in its ability to provide an analysis of neighbourhood wellbeing over time. This kind of longitudinal analysis will be an essential part of the City's efforts to measure the contribution that its work makes to the neighbourhood outcomes that are important to Council, and to residents, funders and agencies, and will support the work that CSP and other CPIP programs undertake to coordinate the impact of their efforts with those of other funders.

Funder Coordination across the Community Service System

As a part of their ongoing refinement of the CSP, staff work closely with other funders to identify emerging community issues and changes in the policy and funding environment. During this process, two issues with a significant impact on organizations funded through the CSP were identified.

Citizenship and Immigration Canada:

In late 2010, a number of CSP-funded organizations learned that their service delivery contracts with Citizenship and Immigration Canada (CIC) would not be renewed as a result of a change in CIC's settlement program. The impact of this loss on some organizations was significant, although this depended on the size of the contract, the length of time the contract had been in place, the organization's range of services, and on the capacity of the board to manage the change.

Staff have worked with CIC program officers, United Way Toronto and the Provincial Newcomer Settlement Program to help organizations with strategic and financial planning and to adapt to the changes. Organizations have been encouraged to review their service mandates and financial viability, and to consider partnership and merger options where appropriate. As a part of this process, affected organizations continue to work together closely to identify the impact of service reductions on local communities.

Changes to CIC's funding program and its impact on CSP-funded organizations were considered during the review of 2011 funding requests, and related funding conditions are included on the organization's detailed summary sheets in Appendix D.

Ministry of Health and Long Term Care:

The Ministry of Health and Long Term Care administers funding for Elderly Person's Centres in Ontario. These Centres provide social recreation opportunities for seniors that provide them with social supports and help them maintain a healthy lifestyle. Funding for the Centres is governed by Provincial legislation and regulations which stipulate that funding will only be provided when 20% of the Provincial contribution is matched by the local municipality.

For the 2009/10 and 2010/11 Provincial funding years, the Ministry opened its funding programs to new applicants (the program had been closed to new applicants in previous years). To ensure legislated provincial-municipal funding arrangements are met, City staff work with the Provincial program officers to share information on priorities and new service viability. As an outcome of this coordination, the CSP provides \$1,218,810.00 to 41 Elderly Person Centres for seniors in neighbourhoods across Toronto.

Assessment and Allocation Recommendations

Application and Assessment Process:

The CSP assessment is conducted in two stages. First, the program and organization must meet the eligibility criteria to be included for further consideration. Second, eligible programs and organizations must demonstrate their fit and performance against a series of assessment criteria. These eligibility and assessment criteria reflect the CSP Risk Management Framework, and ensure that funding is only recommended to organizations with the capacity to effectively manage and deliver funded programs.

In June 2008, Council approved the report "Options to Streamline and Improve Funding Administration" which provided direction to implement changes in the application, assessment and approval processes for CPIP Partnership programs. The report was requested by the Community Development and Recreation Committee, and it identified options for efficient and lean grant administration processes that would continue to meet the Auditor's requirements, provide accountability for grant funds, and simplify the application process for returning organizations.

During the 2009, 2010 and 2011 CSP funding cycles, the report's recommendations have been implemented in the following areas:

- flexibility for partnership organizations to transfer funds within an approved budget and between approved programs has been implemented;
- the funding cap for the Community Services Partnership program has been increased;
- multi-year funding periods for partnership programs are now in place; and
- delegated approval for some partnership allocations is an available option.

There have been additional simplifications in the application process for returning CSP organizations with the implementation of the on-line Corporate Grants Information System (CGIS). In future funding years, staff will be working to ensure the online application system is efficient for other CPIP programs as they introduce this option to their applicants.

To further streamline funding administration in 2012, the CSP guidelines and assessment processes will be reviewed. One of the key tasks of this review will be to identify additional options for the implementation of multi-year funding periods.

The 2008 Options report also identified the need to review the CSP funding cap, which is currently set at \$75,000.00 per funded program, every three years. With the transfer of other funding streams into CSP (including FSIP, Snow Shovelling and Lawn Care, and Major Recreation), three program allocations currently exceed the CSP's cap. These programs will be maintained at their previous funding level to reflect their historical allocation, and no changes to the CSP's program cap are recommended at this time.

Allocation Framework and Priorities:

Within the CSP, organizations apply for program-specific funding. Because funded programs address ongoing needs, maintaining support to previously funded programs is the first priority in the allocation of CSP funds. Subject to budget constraints, programs funded in one year that are assessed as complying with all of the CSP criteria in subsequent year are recommended for the same level of support. Requests for new and increased funding are prioritized using the CSP mission statement and CSP Equity Framework, which considers geographic equity, service equity and community of common bond equity.

In 2011, the CSP budget was approved with no increase to address ongoing issues of rising costs for program delivery in the community services sector. As a result of this Council decision, economic factors have not been considered in the 2011 CSP allocation process, and cost of living increases to allocation levels have not been provided. Funded organizations will be expected to absorb any inflationary costs within their existing operations.

Overview of 2011 CSP Applications:

In 2011, six new organizations submitted applications for funding. Three of these organizations were determined to be eligible under the eligibility criteria, and their applications were considered along with other requests for new and increased funding. The other three new applicant organizations were determined to be ineligible for CSP funding, and did not proceed to the second stage of the assessment process. All six new organizations and their status under the CSP are listed in Appendix C.

A total of 228 eligible organizations submitted applications for 542 programs under the 2011 CSP. Of these eligible organizations, 78 submitted requests for new and increased funding. This group of applicants is the subject of this report's recommendations, and the details of their requests are included in Appendices A and D. A total of \$4,693,781.00 is available to respond to these requests, \$4,658,646.00 of which is recommended for allocation as described in Appendix A. These recommendations include \$28,000.00 in increased funding for one returning program. An amount of \$35,135.00 has been held for appeals of these recommendations.

The 2011 CSP also includes snow shovelling and lawn care services that allow seniors and people with disabilities to remain safely in their homes for as long as possible. Funded organizations maintain the service delivery models they used prior to amalgamation, and as a result, there are both brokerage and claims-based services funded

under the CSP. In 2005, Council approved the continued use of the individual rebate model for clients in the former City of York who were already receiving services. Rebates are based on claims made directly to the City by eligible seniors, and are administered by the Community Funding Unit. An amount of \$12,000.00 has been held from the CSP 2011 Approved Operating Budget to address these claims.

A total of 150 organizations submitted flat line requests for funding, and under the streamlining policy, these applications have been approved by the Executive Director, Social Development Finance and Administration. Details of the assessment and allocation results for those organizations that applied for flat-line allocations are available on the City's website at www.toronto.ca/grants/csp.

The assessment process also identified a small number of returning organizations that did not demonstrate satisfactory performance against the CSP assessment criteria. These performance issues are documented on the detailed summary sheets included in Appendix D, and where appropriate, funding conditions have been applied to ensure criteria are met in a timely manner.

During the course of 2011, some approved organizations may not be able to make full use of their CSP allocation. This situation can arise when organizations are unable to meet the conditions of their funding, or it can arise as a result of organization and program closures. This report requests delegated authority that would allow the Executive Director, Social Development, Finance and Administration, to reallocate any 2011 CSP funds that are not used during the funding year by approved organizations to another CSP approved organization.

Major Recreation Funding:

Starting with the 2011 funding cycle, Parks Forestry and Recreation transferred the administrative responsibility for recreation funding programs to the Social Development, Finance and Administration division. This transfer is consistent with other past administrative changes that have brought the Food Security Investment Program and the Snow Shovelling and Lawn Care program into the CSP program.

In order to streamline funding administration in this transition year, Major Recreation funding has been administered through the CSP on-line submission database, and assessed within the CSP review process for the majority of applicants. Four organizations received Major Recreation grants in 2010 but did not receive funding under the CSP during the same period. The assessment and allocations for these four organizations are included in report on the Community Recreation Investment Program, which is also before Committee at its June 29, 2011 meeting.

Over the next several months, staff will review the need for any changes to the administration of the Major Recreation program. Changes to the program's priorities may also be considered to ensure that community-delivered recreation activities complement City-delivered activities. City-delivered activities are currently being reviewed as a part of the development of a Recreation Service Plan.

Recommendation Summary:

Of the 228 organizations requesting funding, recommendations are made for program funding for 226 organizations. The 2011 CSP recommended allocations for organizations that requested new and increased funding are summarized in Table 1:

CSP funded organizations define their catchment areas based on geography, transportation routes, usage patterns, administrative boundaries (such as wards), distribution of the target population, and other factors relevant to their communities. CSP has identified a general category for each funded organization based on how far reaching their services are:

- Local: services are primarily designed for a ward, neighbourhood, small group of adjacent neighbourhoods, or other smaller geographic area;
- Service Area: services are primarily designed for a group of wards, a larger group of neighbourhoods, or larger areas such as former municipalities;
- City-wide: services are designed for communities that are spread across the city, or the service is specialized and draws people from across the city.

In 2011, 37 CSP-funded organizations provide Local services, 78 provide Service Area services, and 111 provide City-Wide services.

2) Jane Alliance Neighbourhood Services

The organization has requested funding of \$28,000.00 for the Computer Literacy Program for Seniors, offered in partnership with George S Syme Seniors Centre of York.

The organization is not eligible for funding under the 2011 CSP. The organization does not show diverse and stable funding sources. The application did not demonstrate that the organization has the required organizational and financial systems and structures to

deliver the proposed program. The application was incomplete; the organization did not submit a reserves policy and guidelines, anti-racism, anti-discrimination and access policies, and an organization income budget. The organization did not provide an audit and the current financial situation could not be verified.

The organization is encouraged to develop its financial management skills and pursue partnership opportunities to build on its program delivery commitment.

3) Scarborough Senior Tamil Association

The organization has requested funding of \$ 20,000.00 for the Taking Care of Tamil Seniors program which works with Tamil seniors in Scarborough (Malvern) to reduce social isolation.

The organization is not eligible for funding under the 2011 CSP. The application submitted is incomplete. The organization did not submit a reserves policy and guidelines, anti-racism, anti-discrimination and access policies, and an organization income budget. The organization and program budgets were incomplete and the organization did not submit a financial audit and therefore the financial situation of the organization could not be verified. The organization did not demonstrate that it has the organizational and financial systems to meet the CSP requirements for accountability.

The organization is encouraged to develop its financial management skills and pursue partnership opportunities to build on its program delivery commitment.
