Notice was given and a Public Hearing was held on Thursday, April 28, 2011, as required by the Planning Act.

PURPOSE OF THE APPLICATION:

This is an application to permit the construction of a new Bus Terminal-Substation Building as part of the Finch West Station of the Toronto-York Spadina Subway Extension.

REQUESTED VARIANCE(S) TO THE ZONING BY-LAW:

North York By-law 7625

- 1. Front yard setback of 0m to the proposed building and canopy WHEREAS a minimum setback of 9m is required;
- 2. No landscaping to be provided along the Keele Street frontage WHEREAS except for driveways entering and exiting directly from the lot onto the street, a minimum distance of 1m from all lot lines that abut a street shall be landscaped; and
- 3. Proposed to have 37% (538m²) of landscaping within the front 9m setback (63% hard surface) WHERES no more than 50% of the minimum front yard setback shall be covered with driveways, walkways or other hard surfaces
