Notice was given and a Public Hearing was held on Wednesday, July 13, 2011, as required by the Planning Act.

#### PURPOSE OF THE APPLICATION:

To convert the existing two-storey vacant former industrial building on the site into residential purposes and to construct a two-storey addition above it. The building as altered will be four storeys and will contain a total of nine residential dwelling units.

### REQUESTED VARIANCE(S) TO THE ZONING BY-LAW:

#### 1. Section 9(1)(F), By-law 438-86

Dwelling units are not permitted in the third and fourth floor addition. In this case, dwelling units are proposed in the third and fourth floor addition.

#### 2. Section 9(3) Part II 1, by-law 438-86

The minimum required setback of the third and fourth floor addition from the front lot line is 2.42 m. The proposed third and fourth floor addition will be located 0.00 m from the front lot line.
