Dear North York Community Council:

Re: Downsview Secondary Plan Consideration, June 22, 2010

As president of the Balmoral Homeowners Association and as chair of the Committee to Save Our Ramps, I have been trying through Mike Feldman's office to determine at what time the Downsview Secondary Plan will be considered on June 22nd. I have not been able to obtain as yet a clear answer. I understand that the Lawrence Heights issue is to be considered starting at 2:15 p.m. and that there will likely be hundreds of citizens who will wish to address council on that issue.

Will the North York Council be deferring our issue to the August meeting? Will the North York Council be considering our issue on the following day, June 23rd? Many concerned citizens want to address the Council with respect to the Downsview Secondary Plan but they cannot afford to come and wait all day with respect to an issue that might not even be reached.

I need to inform the members of our community on Monday at what time they should come to the Council meeting. I therefore am asking you to be proactive immediately in order to try to let me know what the timing will be.

On an urgent basis, I am asking you to consult with whomever needs to be consulted. Ms N. Oomen of Mike Feldman's office has written to me as follows:

Lawrence is item NY35.67 @ 2:15 p.m., it is the last item on the agenda.

As I mentioned it is a heavy agenda and many other items are timed in the morning and 3 in the afternoon. Lets wait and see what happens on Tuesday morning.

At the moment Downsview is NY35.64 and not time specific which means that if it does get debated/dealt with it will be done after all the timed items have been completed, as well as all the other items on the agenda that are not. There is no telling how long it will take to go through everything.
