#### Background

- Road Right-of-way
- Coordination Process

#### **Recent Construction Issue**

 Potential for excavation of freshly placed concrete sidewalk



# **Road Right-of-Way**

### **Function of ROW**

- Safe and efficient transportation access
- 'Store front' to local businesses and services
- Utility corridor

#### Work in the ROW

- 5,600 km of roadway, 8,000 km of sidewalk
- 70,000 occupancy (60,000 cut) requests /yr
- Emergency Work & Planned Maintenance Construction



# **Coordination Process**

#### Toronto Public Utility Coordinating Committee (TPUCC)

- City and Utilities
- Extensive involvement, well established in coordination process
- Monthly issues discussion,
- Spring/Fall program meetings by district
- Specific Project discussions/correspondence



## **Coordination Process**

#### **Overview**

- Systematic and extensive
- City identify and coordinate internally
- Preliminary program disclosure to TPUCC
- TPUCC contribute scope of works and additional project identification
- Sequential or concurrent works



# **Coordination Context**

#### **Constructor Issue**

- Occupational Health & Safety Act
- Managing risk of significant legal obligations and liabilities
- Separation in time and space



# **Coordination Context**

#### **Construction Moratorium**

- Published Annually
- Applied following major road and sidewalk works
- Prohibits planned construction by City and Utilities
  - 3 yrs resurfaced roadway
  - 5 yrs reconstructed roadway/ sidewalks



# **Coordination Context**

#### **Construction Moratorium**

- Benefits
  - maximize the life of renewed City infrastructure
  - minimize costs
  - minimize public disruption caused by construction
- Routinely and regularly applied to road cut applications



## **Coordination Results**

- Various lists and maps since 2004
- City & Utility Capital works
- Road Moratoriums





# **Continuous Process Improvement**

#### DCM Cluster B, Major Capital Infrastructure Coordination Office

- Coordination process improvements
- 5 year coordinated capital works program
- Detailed tracking and mapping
- Engaged in planning/coordination of large scale, complex projects (Provincial Campus, Pan Am etc)



# Dundas St. W

#### **Reconstruction Project**

- 2010/2011 Bathurst Street To Howard Park
- Includes road, sidewalk and boulevard reconstruction

#### **City Coordination Activities**

- Extensive internal and external coordination
- All utilities engaged through TPUCC
- Coordinated works in prior years
  - Bell and Rogers Cable works
  - Enbridge replaced a portion of their infrastructure in 2007
  - Extensive City construction (TTC track, water and sewer)

### **Construction Issue**

#### **Enbridge's Request**

- Immediately prior to May 2011 construction start up
- Routine Leak Detection Program identified some corrosion that may become an issue in future years
- Request to replace 13 risers within first construction area, post construction





## **Construction Issue**

#### **City's Response**

- City <u>rejected</u> Enbridge's request
- Deemed as non-emergency activity
  - not appropriate due to extensive public and community commitments and contract obligations

#### The City offered accommodations :

- City would 'box out' areas (not immediately place the concrete) where Enbridge wanted to do their work
- Enbridge was offered access to areas outside of our contractors active work zone



# **Construction Issue**

#### **Enbridge's Response**

- Began riser replacement outside of active construction area
- Alternate measures to prolong the service life of many risers
- Scaled back to 3 risers versus the original 13
  - in areas where the City has not yet reconstructed
  - will result in no cutting of recently placed concrete

#### **Path Forward**

• City intends to raise this experience with all TPUCC members at its meetings



### Recommendations

- 1. Continued PWI support for staff enforcement of road cut moratoriums
- 2. Annual reporting of construction coordination practices and issues
