THIS MOTION, made by the City of Toronto, for an Order for an interim injunction, was heard this day at the Court House at 393 University Avenue, Toronto, Ontario M5G 1E6.

ON READING the Affidavit of Carlo Casale sworn July 22, 2011 and the Affidavit of David Oner sworn July 24, 2011 and on hearing the Submissions of Counsel for the plaintiff and the Submissions of the defendants:

1. **THIS COURT ORDERS** that the defendants and their employees, agents, directors and officers and anyone else having knowledge of the terms of this Order be restrained from:

- (a) directly or indirectly having any contact with residents of the City of Toronto concerning the removal, retrofitting, replacement or installation of water meters and payment therefor;
- (b) posting on the internet any personal information regarding residents of the City of Toronto who have had water meters removed, retrofitted, installed or replaced at their residences.

2. **THIS COURT ORDERS** that the defendants immediately remove any internet postings that they have caused to be posted containing the names, telephone numbers, addresses or any other personal information of, or statements concerning, residents in the City of Toronto at whose homes the defendants have removed, retrofitted, replaced or installed water meters.

3. **THIS COURT ORDERS** that the costs of this motion fixed in the amount of *and* \$ 2,500.00 *within 30 days* forthwith be paid by the defendants to the plaintiff.
