Enbridge Pipelines Inc. (Enbridge) operates one 762mm diameter high pressure petroleum pipeline contained in a 3.048 m wide right-of-way/easement on the north side of the hydro corridor, as identified in Figure 1 below.

Enbridge has no concerns with the proposed development providing the following conditions are adhered to:

- No permanent structures are permitted within the right-of-way area.
- Enbridge must have the ability to access its' right-of-way at all times for maintenance, inspection and alteration of the pipeline(s).
- Any proposed crossings of the right-of-way by roads, laneways, services and utilities are
 permitted in accordance with the regulations of the National Energy Board (NEB) Act and
 subject to approval by Enbridge's Crossings Co-ordinator, Ann Newman at (519) 339-0503.
 The applicant will be required to enter Enbridge's Standard Crossing Agreement.
- Enbridge is regulated by the National Energy Board (NEB) Act. Section 112 of the Act requires any excavation within 30 meter of Enbridge's right-of-way to be approved by Enbridge.
- No grading or placing fill on Enbridge's right-of-way will be permitted without prior approval
 of Enbridge.
- No work shall take place on Enbridge's right-of-way without the presence of an Enbridge inspector.
- No heavy machinery will be permitted to cross Enbridge's right-of-way without prior approval.
- No landscaping shall take place on Enbridge's right-of-way without Enbridge's approval.
