PURPOSE OF THE APPLICATION:

To demolish a two-storey dwelling and construct a new two-storey dwelling with an integral garage.

REQUESTED VARIANCE(S) TO THE ZONING BY-LAW:

1. Section 6 (3) Part II By-law 438-86

The maximum permitted gross floor area is 0.6 times the area of the lot (292.57 m^2) . The new dwelling will have a gross floor area is 0.851 times the area of the lot (415.17 m^2) .

2. Chapter 10.20.40.40(1), By-law 1156-2010

The maximum permitted floor space index is 0.6 times the area of the lot (292.57 m²). The new dwelling will have a floor space index of 0.851 times the area of the lot (415.17 m²).

3. Chapter 10.20.40.70 (3)(C), By-law 1156-2010

The minimum required side yard setback is 1.5 m.

The new dwelling will have a side yard setback of 1.2 m for both the west and east side yards.
