2012 BUDGET BRIEFING NOTE

Eliminate Programming at Selected Shared & Exclusive Use TDSB Schools

Background:

• Parks Forestry and Recreation Division (PF&R) is recommending closing 12 of 29 TDSB shared and exclusive use Community Centres, effective March 1, 2012 for a savings of \$2.111M in 2012 and an additional savings of \$0.656M in 2013.

- All TDSB locations including those identified as Priority Centres and locations within priority neighbourhoods were considered for this service level reduction.
- Each location offers a mix of instructional, drop in and permits opportunities. Programming included arts, music, camps, fitness, dance, sports, seniors and leadership.
- In 2010, there were approximately 656,000 participant visits at the 29 TDSB locations citywide, and more than 15,000,000 total recreation visits across the City.
- Eliminating programming at the 12 locations outlined in this briefing note would affect approximately 232,000 participant visits per year or 35% of the participant visits at the TDSB locations and 1.5% of all recreation visits across the City.

The selected sites were considered against the following criteria:

- A weighted ranking was developed that measures total visits, gross expenditure per visit, net cost per visit and ward visits per capita and compared those measures to the average for each category. These comparisons were used produce a weighted score. All locations above the median weighted score of 0.57 were considered.
- Proximity of selected location to other community centres in a ward or geographic area (within 5 km)
- Sites were excluded if they had low savings.

The Thistletown Multi- Service centre offers both recreation programs and leased spaced to a variety of community agencies, including a daycare centre. The Thistletown Senior's centre also operates from this location. PFR plays a landlord function in this facility subletting space to external agencies and negotiating a single lease with the TDSB. PFR supports all custodial, maintenance and utility costs on behalf of all tenants.

There are no reductions to the seniors centre budget. The seniors' centre activities can be relocated provided that suitable space can be found. Some activities can be relocated to West Acres Seniors Centre

Community agencies will have to negotiate space with the TDSB if the shared use agreement is cancelled. Permitted visits by outside groups accounts for 67% of total visits at Thistletown. Permit groups could approach the TDSB directly to permit the facility.

Participants registered at Thistletown CC can potentially register at nearby locations. There is program capacity at nearby locations.

Locations in close proximity include West Acres Seniors Centre (2.3 km), North Kipling CC (3.1 km), Elmbank CC (3.6 km) and Pelmo Park CC (4.7 km).

There is potential capacity at these nearby locations to accommodate between 50-65% of the lost registration at Thistletown CC.

• Participants in programs at the selected TDSB locations recommended for closure will have the option of accessing programming at other locations with registration capacity. All current participants cannot be accommodated as capacity varies from location to location.

- A district approach was taken to identify available registration space at all nearby locations. This was done due to the complexity of matching individual courses from locations that are selected for closure and available space in programs at nearby community centres. In addition, some TDSB locations have the same locations within 5 km.
- North York District has capacity at nearby locations to accommodate registration due to the recommended TDSB shared use closure.
- Etobicoke York District can only accommodate approximately 50% of the lost registration district wide.
- Toronto East York District can accommodate 100% of lost registration in existing programming.
- Recreation seasonal planning will take in to account program demand created as a result of the closure of the shared use community centres and new or expanded programs will be created wherever possible in existing facilities
