

Notice of Public Meeting
Proposed Changes to User Fees

The Council of the City of Toronto will be considering a proposal to pass by-laws to amend the City of Toronto Municipal Code Chapter 441, Fees, so as to adopt the changes to existing user fees and the new user fees that are proposed in the 2013 Recommended Operating Budget. The 2013 Recommended Operating Budget will be considered by City Council on January 15 to 17, 2013. The required by-laws will be before City Council at its meeting of February 20, 2013.

Attached to this notice is a listing of the changes to existing user fees and new user fees that are proposed in the 2013 Staff Recommended Operating Budget.
