# Supplementary Report on Council's June 6-8, 2012 Decision to Prohibit Single-Use Plastic Carryout (Shopping) Bags

# **SUMMARY**

The purpose of this supplementary report is to advise of court proceedings commenced by the Ontario Convenience Stores Association (the "OCSA") and the Canadian Plastic Bag Association ("CPBA") and to seek instructions from Council respecting these proceedings.

### RECOMMENDATIONS

The City Solicitor recommends that:

- 1. Council adopt the confidential recommendations in the Confidential Attachment.
- 2. If adopted, the confidential recommendations in the Confidential Attachment remain confidential until such time as the action authorized by the adoption of the recommendations is taken.
- 3. All other information contained in the Confidential Attachment remain confidential as it pertains to litigation and contains advice subject to solicitor-client privilege.

# **Financial Impact**

Information on the financial impacts is contained in the Confidential Attachment.

#### **DECISION HISTORY**

The decision history is set out in detail in the initial Staff Report, dated September 17, 2012, from the City Solicitor. City Council previously decided at its December 1-3, 2008 meeting to impose a five cent plastic bag fee and enacted an implementing bylaw on March 31, 2009. City Council subsequently decided at its June 6-8, 2012 meeting to rescind that five cent plastic bag fee and enacted an implementing bylaw on June 8, 2012. City Council also decided at its June 6-8, 2012 meeting to impose a prohibition on single use plastic carryout (shopping) bags.

Since the submission of the initial Staff Report to Council, City Council at its October 1-3, 2012 meeting made the following decision with respect to considering a confidential report from the City Solicitor and conducting industry and public consultations on a draft bylaw to implement the ban of single use plastic bags and on related issues. http://app.toronto.ca/tmmis/viewAgendaItemHistory.do?item=2012.CC26.1
