Dear Clerk and Members of Council,

The Toronto Region Board of the Ontario Restaurant Hotel & Motel Association (ORHMA) is writing today to encourage Toronto City Council to support a fiscally responsible budget for the City of Toronto and applaud the efforts of Mayor Ford in seeking to reduce waste, improve efficiencies and improve the processes of departments to better the business climate in the city.

The ORHMA – Toronto Region Board is comprised of a cross-section of owners and operators representing Toronto's 8,000 restaurateurs. Our membership is comprised of business owners who know too well the pressures of fiscal restraint. As business owners/operators in Toronto, we support fiscal responsibility in all levels of government and we commend the Mayor's efforts to run the City in a prudent businesslike fashion

Responsible governments have a unique opportunity now to return integrity to a process that has been muddied in the past by mismanagement and impediments to progress for businesses. The amount of consultation on this particular budget is encouraging to the restaurant industry that has struggled to have our issues and concerns heard in the past. We are encouraged because the budget contains elements which are in line with priorities the Toronto Region Board of ORHMA has called for in the past. The open for business approach of streamlining processes, outsourcing where necessary and feasible, and the reduction of red tape are all issues the Toronto Region Board of ORHMA has advocated for on behalf of our own industry.

As business owners we can appreciate and acknowledge the difficulties faced by The City of Toronto in preparing the 2012 Budget to address the pressure of a \$774 million gap, reduce its reliance on one-time revenues, bring spending back in line with revenue growth, and moderate capital financing pressure. Though our operating budgets and margins are much less grandiose, we are forced to control our expenses daily or face closing our doors. A municipal government that is willing to take the same approach as we do in our own operations, is indeed a responsible government.
