This letter is to request the approval for the service and sale of alcoholic beverages at the Toronto Blue Jays Canada Day Street Festival. The date of the event is Sunday July 1st from noon till 3pm. There is a request for road closure on the north side lanes of Bremner Ave. from 6AM till 5PM. The south side lanes of Bremner Ave will remain open and maintain two-way traffic. The Canada Day Street Festival will take place around the entire Rogers Centre. The licensed area will be located on the south-west side of the building outside of Gate 10 and 11. It will be surrounded by a 6ft fence with a main entrance and exit gate as well as two emergency exit gates. Labatt's Budweiser Big Rig will be onsite as well. It will be parked on Bremner Ave in the north side lanes between Navy Wharf Cres and Van De Water Cr and will be considered a part of the licensed area.
