PURPOSE OF THE APPLICATION:

To demolish the existing dwelling and to construct a three-storey semi-detached dwelling with an integral single car garage.

REQUESTED VARIANCE(S) TO THE ZONING BY-LAW:

1. Section 330-26.B.(4)

The minimum required lot area is 325 m².

The lot area will be 232.3 m².

2. Section 330-26.B.(4)

The minimum required lot frontage is 10.5 m.

The lot frontage will be 7.62 m.

3. Section 330-26.B.(8)

The maximum permitted floor space index is 0.6 times the area of the lot (139.35 m²).

The proposed semi-detached dwelling will have a floor space index equal to 0.75 times the area of the lot (174.89 m^2) .
