## PURPOSE OF THE APPLICATION:

To construct a rear two-storey addition to the existing two-storey semi-detached dwelling.

# REQUESTED VARIANCES TO THE ZONING BY-LAW:

#### 1. Section 6(3) Part I 1, By-law 438-86

The maximum permitted gross floor area is 1.0 times the area of the lot (156.82 m<sup>2</sup>). The altered dwelling will have a gross floor area 1.03 times the area of the lot (161.09 m<sup>2</sup>).

#### 2. Section 6(3) Part II 3, By-law 438-86

The minimum required side yard setback is 0.45 m.

The altered dwelling will have a side yard setback of 0 m on the north side.

#### Section 6(3) Part II 5, By-law 438-86 3.

The maximum permitted dwelling depth is 17.0 m.

The altered dwelling will have a depth of 25.48 m.

#### 4. Section 6(3) Part III 1 (a), By-law 438-86

A minimum of 30% of the lot area shall be maintained as landscaped open space (47.04 m<sup>2</sup>). In this case, 22.8 % of the lot area will be maintained as landscaped open space (35.76 m<sup>2</sup>).
