Notice was given and a Public Hearing was held on Thursday, January 12, 2012, as required by the Planning Act.

PURPOSE OF THE APPLICATION:

This is an application to permit the existing front yard hard surface and the accessory structure (stone barbeque/fireplace) attached to the rear of the dwelling to be maintained as constructed. Circular driveways are permitted on lots having a frontage greater than 18m. The subject lot has a frontage of 18.28m. Due to the accessory structure being attached to the rear of the dwelling, it is deemed to be part of the dwelling for length and setback requirements,. The accessory structures in the rear yard (detached garage and tree house) comply with the By-law requirements.

REQUESTED VARIANCE(S) TO THE ZONING BY-LAW:

North York By-law 7625

- 1. Front yard landscaping of 55.4% WHEREAS a minimum front yard landscaping of 60% is required;
- 2. West side yard setback of 1.17m to the structure WHEREAS a minimum setback of 1.8m is required; and
- 3. Building length of 17.56m including the rear accessory structure having a WHEREAS a maximum building length of 16.8m is permitted.
