On-street Car-Share Vehicle Parking Installation Criteria and Permit Fees

Installation Criteria

Each location for a Car-Share Vehicle Parking Area (CVPA) must satisfy the following criteria:

General Criteria:

- At every location where a CVPA is requested, vehicles must be able to park at all times of the day and all days of the week;
- Each proposed location must not be located closer than 30.5 metres to an intersection controlled by traffic control signals or 9 metres of an uncontrolled intersection or intersection controlled by "Stop" signs or "Yield" signs.
- The location of a requested CVPA will not adversely impact on safe and efficient traffic operation;
- The CVPA should be located close to one or more TTC routes; and
- Each proposed CVPA location must be acceptable to the Ward Councillor.

In addition to the general criteria noted above, all requested CVPAs that will be located on a section of a street where residential permit parking is authorized must also satisfy the following specific criteria:

Specific Criteria – Residential Permit Parking Area

- The CVPA will not be located in a low-density residential zone (in front of single family homes); and
- The residential permit parking area must not be wait-listed for permits.

Permit Fees

The following fees will apply for the application and permits related to Car-Share Vehicle Parking areas:

Tier 1 Car-Share Vehicle Parking Permit (per space)	\$ 708.84 per year pro-rated monthly
Tier 2 Car-Share Vehicle Parking Permit (per space)	\$1284.60 per year pro-rated monthly
Tier 3 Car-Share Vehicle Parking Permit (per space)	\$4400.84 per year pro-rated monthly
Supplementary Car-Share Vehicle Parking Permit (per vehicle)	\$ 50.00 per year pro-rated monthly
Replacement Fee (per permit)	\$ 28.00

All fees are subject to applicable taxes and an annual inflationary increase

Application Fee – This fee will be charged for each application for the designation of a new Car-Share Vehicle Parking Area. This fee is non-refundable. If the CVPA is approved, the applicant will be responsible for the cost of installing signs and pavement markings to delineate the area.

Car-Share Vehicle Parking Permit – This fee will be charged for each space within the Car-Share Vehicle Parking Area and will result in the issuance of one window decal permit per space. The annual fee for each tier of permit applies to the fiscal year (December 1 to November 30) and is pro-rated monthly. A Tier 1 Permit is the base fee, a Tier 2 Permit applies to spaces on a street where on-street residential permit parking spaces would be replaced, and a Tier 3 Permit applies to spaces on a street where pay-and-display parking spaces would be replaced.

A **parking space** is considered to occupy an area of 5.5 metres in length by 2.0 metres in width, or a total area of 11.0 square metres. A Car-Share Vehicle Parking Area may contain more than one parking space.

Supplementary Permit – this fee will be charged for each additional permit issued to allow vehicles belonging to a car-share company/organization to use the Car-Share Vehicle Parking Areas for which Car-Share Vehicle Parking Permits have already been issued to that same company/organization.

Replacement Fee – This fee will be charged to replace a window decal permit that has been lost or stolen.
