The Council of the City of Toronto proposes to pass a by-law to permanently close a portion of the public highway, Kirkhams Road, designated as Parts 1 on Sketch No. PS-2011-007.

At its meeting to be held in the Scarborough Civic Centre on February, 14, 2012 commencing at 9:30 a.m., the Scarborough Community Council will hear in person or by his or her counsel, agent or solicitor, any person who wishes to speak to this matter.

The City will also make your communication and any personal information in it - such as your postal address, telephone number or e-mail address - available to the public, unless you expressly request the City to remove it.

The City videotapes committee and community council meetings. If you make a presentation to a committee or community council, the City will be videotaping you and City staff may make the video tapes available to the public.

This notice shall also constitute notice to the public of the proposed public highway closure in accordance with the requirements of the Municipal Class Environmental Assessment for Schedule A+ activities.
