# Extension of Overnight On-Street Permit Parking Hours – Pirandello Street and Western Battery Road

#### SUMMARY

This staff report is about a matter which Community Council has delegated authority from City Council to make a final decision.

Transportation Services is requesting approval from Toronto and East York Community Council to extend the overnight on-street permit parking hours on Pirandello Street, between East Liberty Street and Western Battery Road and on Western Battery Road between East Liberty Street and Pirandello Street, from 12:01 a.m. to 7:00 a.m., 7 days a week to 6:00 p.m. to 9:00 a.m., 7 days a week.

By extending the overnight on-street permit parking hours, the Parking Enforcement Unit, Toronto Police Service, can effectively control long term parking, through tagging and towing operations.

## RECOMMENDATIONS

#### **Transportation Services recommends that Toronto and East York Community Council:**

1. Authorize an extension to the overnight on-street permit parking hours of operation on the east side of Pirandello Street, between East Liberty Street and Western Battery Road and on the east and north sides of Western Battery Road between East Liberty Street and Pirandello Street, from 12:01 a.m. to 7:00 a.m., 7 days a week to 6:00 p.m. to 9:00 a.m., 7 days a week.

#### **Financial Impact**

The amount of \$600 is available within the current Toronto Transportation Services 2012 Operating Budget.

#### **ISSUE BACKGROUND**

A request was received from Councillor Mike Layton, on behalf of area residents, to extend the overnight on-street permit parking hours on Pirandello Street, between East Liberty Street and Western Battery Road and on Western Battery Road between East Liberty Street and Pirandello Street, from 12:01 a.m. to 7:00 a.m., 7 days a week to 6:00 p.m. to 9:00 a.m., 7 days a week.

#### COMMENTS

Pirandello Street, between East Liberty Street and Western Battery Road is a local street operating in a two way north/south bound direction, on a pavement width of 8.8 metres. There is no TTC Service on Pirandello Street. Parking is allowed on the east side of the street, for a maximum period of 3 hours, with overnight permit parking in effect from 12:01 a.m. to 7:00 a.m., 7 days a week. Parking is not allowed on the west side of the street.

Western Battery Road, between East Liberty Street and Pirandello Street is a local street operating in a two way north/south and east/west bound direction, on a pavement width of 7.3 metres. There is no TTC service on Western Battery Road. Parking is allowed on the east and north sides of the street for a maximum period of 3 hours with permit parking in effect from 12:01 a.m. to 7:00 a.m., 7 days a week. Parking is not allowed on the west and south sides of the street.

Area residents requested an extension to the overnight on-street permit parking hours on Pirandello Street, between East Liberty Street and Western Battery Road and on Western Battery Road, between East Liberty Street and Pirandello Street, to alleviate the problem of long term parking.
