ORDER

A public health inspection of the mobile food preparation premises operating from the municipal address of 250 University Avenue (corner of Simcoe Street and Queen Street West) was conducted on Thursday, November 24, 2011 and critical health violations were observed resulting in an order to close.

I, Anna Ren, Public Health Inspector for the City of Toronto Health Unit order you to take the following actions:

1. Close the mobile food preparation premises and remain closed until all significant and critical violations (as listed in the Food Safety Inspection Report) are corrected in the opinion of a Toronto Public Health Inspector; and
2. Do not obstruct or remove the Toronto Public Health "red closure" placard until authorization has been granted by a Toronto Public Health Inspector.

THE REASONS FOR THIS ORDER ARE THAT:

1. The mobile food preparation premises was being maintained in a manner permitting a health hazard, namely a rodent (mouse) infestation. Note that there was evidence of an active mouse infestation inside throughout the hot dog cart and the fixed tent / tarp structure surrounding the hot dog cart with observations including: numerous mouse droppings (150+) were observed throughout on shelving, on the floor / ground, in the hot dog cart, and on equipment, four (4) 'older' dead mice observed in the metal box trap, one (1) 'fresh' dead mouse observed in an open plastic container under shelving, a strong odour of rodent urine and feces, and evidence of shredded insulation material and 'dust/hair balls' apparently used as rodent nesting material.
2. There was no supply of hot or cold running water at the hand sink (and there was no storage of extra water to re-supply the empty tank).
3. The operator failed to properly wash hands prior to commencing work and while at work handling food as there was no water and no paper towels.
4. The mobile food preparation premises was being maintained in an unsanitary condition including: an accumulation of food debris, moisture, and litter throughout on the ground, an accumulation of grease, dust, and dirt on the fixed tent / tarp structure, the light fixtures, and on old damaged sections of the hot dog cart, and an accumulation of and contamination from the numerous rodent droppings throughout the premises.
5. Some of the food products were being stored directly on the ground and not on racks or shelves at least 15 cm off the ground.
6. There was no sanitizer (i.e. bleach/water spray) available on site to ensure for proper sanitizing of utensils as often as necessary and there were no spare clean tongs and knives.
7. There was a lack of accurate indicating thermometers for some of the refrigeration units on site.
8. There were no durable, pest-proof, and leak-proof garbage containers with tight-fitting lids on site.

I AM OF THE OPINION ON REASONABLE AND PROBABLE GROUNDS THAT:

1. A health hazard exists in the health unit served by me; and
2. The requirements specified in the order are necessary to decrease or eliminate the health hazard.

NOTICE

TAKE NOTICE THAT you are entitled to a hearing by the Health Services Appeal and Review Board if you deliver to me and to the Health Services Appeal and Review Board, Health Boards Secretariat, 151 Bloor St. West, 9th Floor, Toronto, Ontario, M5S 2T5, notice in writing, requesting a hearing within fifteen (15) days after service of this Order.

AND FURTHER TAKE NOTICE THAT although a hearing may be requested, this Order takes effect when it is served on you.

FAILURE to comply with this Order is an offence for which you may be liable, on conviction, to a fine of not more than \$5 000 (for a person) or \$25 000 (for a corporation) for every day or part of each day on which the offence occurs or continues.
