## SUMMARY

This staff report is about a matter for which the Toronto and East York Community Council has delegated authority from City Council to make a final decision.

To report on the temporary relocation of two curblane vending vehicles located at 255 Front Street West, Metro Toronto Convention Centre in order to accommodate the loading and unloading of bus passengers for the Microsoft World Partner Conference.

## RECOMMENDATIONS

#### Municipal Licensing and Standards recommends that the Toronto and East York Community Council:

1. Approve the temporary relocation of two curb-lane vehicles to approximately 20 metres east side of John Street, on Front Street West from July 8 – 12, 2012.

#### **Financial Impact**

There are no financial implications resulting from the adoption of this report.

#### **DECISION HISTORY**

On July 13, 2011 Microsoft announced that they had selected Toronto as the site for the 2012 Microsoft World Partners Conference. The conference will take place July 8 - 12, 2012. As part of the Microsoft World Partners Conference, the attendees will be staying at some 33 different hotels in and around Toronto and as such Microsoft has hired Stewart Transportation Solutions Inc. to provide shuttle service for the attendees.

Stewart Transportation Solutions Inc. will be running multiple coaches and will require curb spaces for drop off and pick up around the Air Canada Centre and Metro Toronto Convention Centre North (Front St. south side). The curb-lane closure of Front Street West in front of the Metro Toronto Convention Centre North entrance would be from John Street to Simcoe Street and would be in effect during the following dates and times:

Sunday, July 8: 7:00 am – 6:00 pm Monday, July 9: 12 noon – 9:00 pm Tuesday, July 10: 12 noon – 12 midnight Wednesday, July 12: noon – 12 midnight Thursday, July 13: 6:00 am – 6:30 pm

The relocation of the two curb-lane vendors located at Front Street West, south side, 163.0 metres east of John Street and Front Street West, south side, 65.56 metres west of Simcoe Street is required to accommodate the bus shuttle services and curb-lane closure.
