

## **Realignment of Permit Parking Area "6C" to exclude 297 College Street**

### **SUMMARY**

---

Transportation Services is requesting authority from City Council to amend the boundary of Permit Parking Area 6C.

Transportation Services has assessed the realignment of Permit Parking Area 6C to exclude the property located at 297 College Street, as requested by Toronto and East York Community Council. We are recommending approval of the realignment as it will not negatively impact on the Permit Parking Area.

### **RECOMMENDATIONS**

---

**Transportation Services recommends that:**

1. City Council authorize the amendment to Schedule B of the City of Toronto Municipal Code, Chapter 925, Permit Parking, to incorporate a revised map of permit parking area "6C", as attached in Appendix "A" of the report (September 20, 2012) from the Manager, Right of Way Management, Transportation Services, Toronto and East York District.

## **FINANCIAL IMPACT**

There is no financial impact associated with this report.

## **ISSUE BACKGROUND**

Toronto and East York Community Council at its meeting on September 11, 2012 in considering motion TE18.7, dated September 11, 2012 from Councillor Adam Vaughan, requested that Transportation Services initiate the process under Chapter 925, Permit Parking, to incorporate a revised map of Permit Parking Area "6C" to exclude the property at 297 College Street.

## **COMMENTS**

Permit Parking area 6C is bounded by Bathurst Street, College Street, Spadina Avenue and Dundas Street West. Permit area 6C has a total of 234 on-street parking spaces. Currently this area is waitlisted, meaning the demand for overnight on-street parking permits has exceeded the supply of parking spaces. There is TTC service provided on College Street. Residents neighbouring 297 College Street support this action as a means of ensuring that this new development does not negatively impact the Permit Parking supply to the existing neighbourhood.

As required under the City of Toronto Municipal Code, Chapter 925, Permit Parking, the General Manager requested the City Clerk to provide Notice. A Public Notice was placed in a major newspaper requesting those objecting to the exclusion of 297 College Street, from permit parking area "6C" to forward their objections in writing to the City Clerk, so they may be scheduled as deputations at the Toronto and East York Community Council meeting. The City Clerk's office has confirmed that no objections have been received.

Transportation Services has no objection to the exclusion of 297 College Street from permit parking area "6C".
