# Mandate of the Office of the Office of the Lobbyist Registrar (OLR)

The OLR's mandate is to maintain a registry of lobbyists and lobbying activities that is available to the public; and to regulate the conduct of lobbyists who lobby City public office holders.



# Mandate of the Office of the Lobbyist Registrar

- The City of Toronto Act, 2006 (COTA) requires the City to establish and maintain a registry of lobbyists that shall be available to the public and authorizes the City to appoint a registrar.
- Chapter 140 of the Toronto Municipal Code establishes the lobbyist registration system and Code of Conduct.
- Chapter 3 establishes the Lobbyist Registrar as an independent accountability officer of the City.



#### Functions of the OLR

#### The functions of the OLR include:

- Maintaining the lobbyist registration system including review, verification and approval, refusal, suspension or revocation of registrations
- Advising, providing opinions and interpreting Chapter 140



#### Functions of the OLR

- Conducting inquiries under s. 169 of COTA to determine if Chapter 140 has been breached – Registrar may report to Council
- Enforcing Chapter 140 breach is a provincial offence



### 2013 Operating Budget Highlights

2013 Operating Budget Request of \$1,065.4 k net includes:

- base budget pressure of \$50.2 k net due to progression pay and benefit increases, reversal of gapping and economic factor adjustments for non-payroll items
- budget reduction of \$57.1 k net or 5.3% of 2012 Approved Net Operating Budget
- budget reduction achieved through reduced salary and non-salary costs
