2013 OPERATING BUDGET BRIEFING NOTE

Itemizing Division Reductions and Changes in Revenue in Economic Development and Culture

Issue / Background:

At its meeting on December 3, 2012, the Budget Committee requested the General Manager, Economic Development and Culture, to provide a briefing note itemizing the \$188,900 reduction in "other expenditures" and \$307,300 increase in "other revenues" (per page 18 of the Analysts' Notes). It is noted that the change in revenue reported in the Analysts Notes is actually a decrease in revenue.

Key Points:

The Changes to the "Other Expenditure" and "Other Revenues" category are the net result of the various changes that are recommended to the Economic Development and Culture Division's Budget, as explained in the Analysts' Notes (page 18).
