Subject: Lawn Bowling Clubs and Park Permit Fees

Committee Decision:

The Parks and Environment Committee, among other things:

1. Referred consideration of current lawn bowling club and park permit fees to the 2013 budgetary process for review.

Decision Advice and Other Information:

The Parks and Environment Committee also requested the General Manager, Parks, Forestry and Recreation to work with the Executive Director, Social Development, Finance and Administration, to assist in the creation of a Lawn Bowling Advisory Group (LBGA) made up of stakeholders in the sport and City staff; to mandate the LBGA to ensure the long term sustainability of lawn bowling in Toronto to maximize the public benefit offered by lawn bowling facilities and to investigate opportunities for outreach programs with youth and seniors.
