Proposed Changes to User Fees

The Council of the City of Toronto will be considering a proposal to pass by-laws to amend the City of Toronto Municipal Code Chapter 441, Fees, so as to adopt the changes to existing user fees and the new user fees that are proposed in the 2014 Recommended Operating Budget. The 2014 Recommended Operating Budget will be considered by City Council on January 29 and 30, 2014.
