ISSUE BACKGROUND

The Director, Purchasing and Materials Management Division and the Executive Director, Engineering and Construction Services recommended the award of Tender 209-2013 to WCC Construction Canada, ULC, being the lowest compliant bidder. A material written objection was received from Bondfield Construction Company Limited which was summarized in PW27.3. As a result of the material written objection, the award of Tender 209-2013 must be done by City Council pursuant to the Purchasing By-law.

COMMENTS

At the November 20, 2013 Public Works and Infrastructure Committee, a closed session discussion was had with respect to PW27.3. The Committee recommended in public session that a report be written to address the issues raised in closed session. The confidential attachment discusses the legal issues as it relates to the issues raised.
