### **Recommendations:**

The Toronto Preservation Board recommends that:

- 1. City Council receive for information the report (October 22, 2013) from the Acting Director, Urban Design, City Planning Division, respecting the Demolition of Four Designated Heritage Properties 266, 276, 284 and 322 King Street West.
- 2. City Council direct that the designated status remain in place until all appeals to the rezoning application are exhausted.
- 3. City Council authorize the appropriate staff to enter into a formal agreement with the property owners to provide an undertaking to guarantee that no demolition permit will be applied for until all appeals on the application have been exhausted.
