Please be advised that 1325084 Ontario Inc., operating as Zipperz Bar, located at 72 Carlton Street East, has made an application for a Temporary Extension of their Liquor Licence during the period of the Toronto Leather Pride weekend, August 4, 2013. This temporary extension is an extension of the presently licenced outdoor area. The extension area is the adjacent parking lot at the rear of the Main Drug Store, located at 70 Carlton Street.

Service times would be limited to the hours of 11:00 a.m. to 11:00 p.m. Occupancy in the extended area would be limited to 263 persons in accordance with the regulations.


This extension is in conjunction with the Leather Pride 2013 weekend festivities. Accordingly, Zipperz intends to provide background music at a level conducive to clientele conversation, announcement functions and normal Zipperz events. The extension has been granted for several years and there have been no difficulties with compliance in the past.

Enclosed please find plans showing the location and size of the area. Please be advised that the site will have a tent (approx 8' x 10') only over the liquor service area. Receptacles will be placed around the area to ensure proper disposal of garbage. Metal temporary crowd barriers 42 inches or higher will be used at the Church Street entrance and security

staff will be positioned accordingly.
