Recommendation

The Board of Health forwards the report (September 28, 2012) from the Medical Officer of Health to the Budget Committee for consideration during the 2013 Transportation Services Division capital budget.

Decision Advice and Other Information

The Board of Health also:

- 1. Commended the Chief Coroner for the important research contained in the Pedestrian Death Review, endorsed the Coroner's recommendations, which identify and encourage life-saving actions to improve pedestrian safety, and urged the Ontario government to act expeditiously to implement the recommendations.
- 2. Requested the Executive Director, Social Development, Finance and Administration to consider the findings of the Coroner's review in the development of the Seniors Strategy.
- 3. Requested the General Manager, Transportation Services Division to attend a Board of Health meeting, within the next four months, to provide a presentation on the City's infrastructure improvements to pedestrian safety and to comment on the Chief Coroner of Ontario's report on Pedestrian Death Review.
- 4.
