**Parking Regulation Amendments – 1141 St. Clair Avenue West**

**SUMMARY**

The purpose of this report is to obtain approval to introduce the "No Parking Anytime" regulation on the south side of St. Clair Avenue West, fronting Jerrett Funeral Home (1141 St. Clair Avenue West). This amendment will provide entrance protection clearance fronting the funeral home entrance main door.

Since the Toronto Transit Commission (TTC) provides service on St. Clair Avenue West, City Council approval of this report is required.

**RECOMMENDATIONS**

**Transportation Services recommends that City Council approve:**

1. Enacting a “No Parking Anytime” prohibition on the south side of St. Clair Avenue West from a point 27 metres east of Westmount Avenue to a point 5.5 metres further east.

**ISSUE BACKGROUND**

Transportation Services staff received a request from Jerrett Funeral Home (1141 St. Clair Avenue West) to implement a "No Parking Anytime" prohibition fronting the funeral home entrance main door. A map of the area is Attachment 1.

## **COMMENTS**

This portion of St. Clair Avenue West is a major arterial road located east of Westmount Avenue and west of Northcliffe Boulevard. The legal speed limit on this road is 50 km/h. There is a sidewalk on both sides of the roadway. Currently, fronting the funeral home entrance main door (south side), there is existing "Pay and Display" parking with "One Hour minimum parking up to Three Hours maximum parking, from 9:00 a.m. to 9:00 p.m., Monday to Friday; 8:00 a.m. to 9:00 p.m., Saturday; 1:00 p.m. to 9:00 p.m., Sunday". This parking exists from a point 15 metres east of Westmount Avenue to a point 15 metres west of Northcliffe Boulevard.

Additionally, a "No Stopping, 7:00 a.m. to 9:00 a.m., Monday to Friday, except for Public Holidays" regulation exists on the south side of St. Clair Avenue West from Westmount Avenue and Northcliffe Boulevard. The City wide three hour maximum applies to all other times. The TTC operates transit service on St. Clair Avenue West.

Transportation Services staff recommends that the "No Parking Anytime" prohibition be implemented on the south side of St. Clair Avenue West fronting the funeral home entrance main door (1141 St. Clair Avenue West).

The implementation of this prohibition will have no adverse affects on traffic operations as two-way traffic flow will be maintained on the street and will provide entrance protection clearance fronting the funeral home entrance main door for their staff. Only one parking space will be impacted by this amendment.
