#### MOTION

### Liquor Licence – 24 Rivalda – Las Brisas Del Mar Restaurant and Lounge

Licence No. 90341

SUMMARY:

Las Brisas Del Mar Ltd.has submitted an application for a liquor licence to the Alcohol and Gaming Commission of Ontario ("AGCO") for a premises at 24 Rivalda Road operating under the name Las Brisas Del Mar Restaurant and Lounge (the "Premises"). The application for additional capacity is as follows: an increase to the indoor capacity from 253 to 350 persons and an increase to the existing patio's capacity from 30 to 40 persons.

The Premises has had, on numerous occasions, incidents to which Toronto Police Services have been called to deal with disturbances related to alcohol consumption. The safety of the community, patrons and staff are a concern. This application for an expanded liquor licence is not in the public interest and the City is requesting that the Registrar of the AGCO issue a Proposal to refuse the liquor licence application.

#### **RECOMMENDATIONS:**

- 1. That City Council direct the City Clerk to advise the Registrar of the Alcohol and Gaming Commission of Ontario ("AGCO") that the liquor licence application for Las Brisas Del Mar Restaurant and Lounge, 24 Rivalda Road (the "Premises"), is not in the public interest having regard to the needs and wishes of the residents, and that the Registrar should issue a Proposal to refuse the liquor licence application.
- 2. That City Council request the Licence Appeal Tribunal ("LAT") to provide the City with an opportunity to be made a party in any proceedings with respect to the Premises.
- 3. That the City Solicitor be authorized to attend all proceedings before the LAT in this matter and be directed to take all necessary actions so as to give effect to this Motion, including adding and deleting conditions to any liquor licence issued for the Premises, in consultation with the Ward Councillor.
