Notice was given and a Public Hearing was held on Thursday, December 6, 2012, as required by the Planning Act.

PURPOSE OF THE APPLICATION:

The existing house has been converted into a Place of Worship. The purpose of this application is to permit the Place of Worship to remain on the main floor with a residential dwelling unit in the basement.

REQUESTED VARIANCES TO THE ZONING BY-LAW:

- 1. To permit a Place of Worship not exceeding a floor area of 100 m² on the main floor of the existing single family dwelling. Whereas the Zoning By-law does not permit a Place of Worship in a Single Family Residential (S) Zone.
- 2. To provide a minimum of 2 parking spaces on the site for the Place of Worship and dwelling unit, WHEREAS the Zoning By-law requires a minimum of 9 parking spaces.

IT WAS THE DECISION OF THE COMMITTEE OF ADJUSTMENT THAT:

The Minor Variance Application is Refused

- The general intent and purpose of the Official Plan is not maintained.
