Recommendations

Councillor Josh Matlow, seconded by Councillor Joe Mihevc, recommends that:

1. City Council authorize the City Solicitor and appropriate staff to appear at the Ontario Municipal Board Hearing to support the Toronto and East York Committee of Adjustment refusal of the consent and variances regarding 204 Balmoral Avenue at the hearing date on April 2, 2013, and if necessary, retain outside planning consultants to support the City's position at the hearing.

Summary

An application for a severence and minor variances with respect to the property known as 204 Balmoral Avenue was heard by the Toronto and East York Committee of Adjustment on November 14, 2012.

The applicant proposed to demolish the existing garage and the north portion of the exisitng dwelling and to construct a new three-storey single family detached dwelling, with an integral single car garage. proposing to demolish the exisitng dwelling, severe the property and construct two new three storey detached dwellings each with a below grade garage.

On November 14, 2012, the Toronto and East York Committee of Adjustment refused both the severance the variance applications.

The Ontario Municipal Board will be considering an appeal to this decision by the Committee of Adjustment at a hearing date on April 2, 2013.
